

ORGANIZATIONAL BACKGROUND

— WHO WE ARE —

People's Forum was founded in 1989 with the goal of giving voice to the weaker and less fortunate members of the community, whose rights have been disregarded, voices have gone unheard, and basic entitlements have not been met.

People's Forum as an organisation was the vision of few benevolent youths who aimed to create a better society by helping people help themselves. Thus, the organisation emerged as a podium for activists who fought for the underprivileged and weaker section of the society.

Since its establishment, the organisation has worked in a variety of disciplines and has looked for more effective ways to connect with the communities that are most excluded. It has never shied away from venturing into uncharted territory or attempting novel approaches to achieving the set organisational goals. It has occasionally taken strong shifts depending on the circumstances and needs.

— HISTORY & INTERVENTION —

Since 1989, the development organisation, People's Forum, that has been around for almost 30 years, has been working on numerous projects in the state of Odisha. People's Forum began its journey by implementing a community awareness and sensitization project, mobilising resources to meet the needs of the communities, and progressively focusing on improving financial inclusion, mental health, education, and livelihood. It started off with a strong emphasis on women as a source of growth and placed a lot of stress on the development of mentally ill women, who are the most vulnerable and generally, the weaker group in society.

The organization entered the field of mental health in 2003, recognizing the urgent need for healthcare, rescue, rehabilitation of distressed women, and general support for mentally ill destitute women, to improve their health and dignity in society. It gradually began to broaden the scope of their activity as the development situation changed and they began to consider the urgent demands of those who were having problems.

Following in the footsteps of Mahatma Gandhi, People's Forum is actively working for the development of underprivileged and vulnerable sectors of society, inspiring efforts towards the holistic development of individuals and communities, including homeless people, elderly individuals, children, and those lacking basic social security.





A. MISSION ASHRA

(REHABILITATION HOME FOR DESTITUTE WOMEN WITH MENTAL ILLNESS)

- Mission ASHRA is the largest rehabilitation centre of eastern India initiated in the year of 2003, and People's Forum has expanded this project in various districts of Odisha to help the most vulnerable group of women with mental illness who are deprived from basic social security.
- It is important to approach mental illness with empathy and understanding, as mental health issues can be challenging for anyone to deal with. From rescue to reunification with family and integration of residents into larger communities with total acceptance, the centre provides individual psychosocial rehabilitation and care to those with mental health problems in a residential environment.

Aim: It aims to provide comprehensive health solutions to the most vulnerable group of the society regardless of their age, religion, caste, social background, or economic status.



VOCATIONAL AND OCCUPATIONAL TRAINING

Mission Ashra not only provides shelters to mentally ill women but also makes sure about their mental & physical growth. To make them a productive member of the society, the mission engages them with a variety of activities such as indoor & outdoor games, Yoga, Crafting etc. Apart from this, occupational training to promote their economic stability.



SUCCESS STORY

One of the first residents of Mission Ashra in the Jajpur District, Durga (Name changed) is a 28-year-old woman. Her brother admitted her. She has experienced a severe stage of schizophrenia since 2018. She was initially very hyperactive. She struggled to establish a connection with the counsellors and other centre staff for up to two to three months. Three months after being admitted, she endured horrible hallucinations. She had already been too aggressive.

By attending counselling sessions, she tried to be a little bit familiar with the counsellor. After developing a relationship with Durga, the counsellor used methods like Cognitive Behaviour Therapy and Cognitive Remediation Therapy. A variety of tests had been given to Durga, including the Rey Auditory Verbal Learning Test, Trail Making Test, Word Association Test, and Insight Scale Test.

Through counselling and therapy, she has improved her communication skills. Additionally, Durga's level of cognition is currently very high. Now she actively participates in every task. Even at present, she is in a mild stage of schizophrenia.

The journey from severe to mild was not easy. The entire team of Mission Ashra Jajpur fully supported Durga. The hallucinations, delusions, and other symptoms are currently absent, and Durga is fine. She is able to recollect details from her past, such as her name and address, that were absent in the initial phase. Within a few months, Durga will be reunited with her family. It's a wonderful accomplishment for Mission Ashra.




B. MISSION AASHALOK

(REHABILITATION HOME FOR DESTITUTE MEN WITH MENTAL ILLNESS)

Mission Aashalok serves as a Rescue and Rehabilitation centre for Mentally ill Destitute Males with a vision to create a safe and supportive rehabilitation centre for the male population. Aashalok – the land of hope, giving the residents all the basic amenities to make them feel at home. This initiative helps address the critical issue of destitute individuals with mental health challenges, a population often marginalised and overlooked. The emphasis on reunion is another heartwarming aspect of Mission Aashalok. This signifies that the centre not only aims to provide immediate care but also strives to reconnect residents with their families or loved ones whenever possible. Reuniting these individuals with their support networks can significantly enhance their chances of successful reintegration into society. To develop their mental & physical state, Aashalok Shelter Home organises various activities to enable the residents to do their work on their own, as this will enable them to not be dependent on others after they are reunited.

SUCCESS STORY

Ajay (name changed), a 19-year-old boy, was rescued on September 11, 2022, from Mahima Chowk in Jharsuguda, thanks to information provided by a journalist. He did not follow any instructions during the 15-day monitoring period and was mostly silent. According to the Psychiatric Doctor, he had schizophrenia. The medication was regularly given to him by our chemist after a doctor recommended it.

Through counselling, therapy, medication, yoga - meditation and other activities, the doctor improved his mental condition, and due to this, he behaved friendly with other residents, and started participating in outdoor activities effectively. After 5 months of his rescue, he can recall his proper address, his family, his past.

After tremendous efforts, the Aashalok team found his correct address with the help of Google, traced it precisely, and got in touch with his family. Ajay was successfully reunited with his father on April 3, 2023, when his father arrived at Mission Aashalok in Jharsuguda. In the present time, he lives happily with his family members. Now he works as a daily wage labourer and gives support to his family & successfully does his daily activities and leads his life with a healthy physical and mental condition. His father was very happy and thanked this institution for his son's care and proper treatment.



C. PHC (PRIMARY HEALTH CENTER)

PHC typically stands for “Primary Health Center.” It refers to the essential health care services that are provided at the community level, focusing on prevention, early detection, and treatment of common health problems. PHC is a fundamental aspect of healthcare systems worldwide, aiming to make healthcare accessible, affordable, and equitable for all.

It is Operated & managed by the People’s Forum in Public-Private partnership Mode in Jodambo and in Gona since 2023.




D. UHWC (URBAN HEALTH AND WELLNESS CENTRE)

‘Urban Health and Wellness Centre’ is a healthcare facility located in urban areas that aims to provide comprehensive primary health services and promote wellness among the urban population. People’s Forum has taken up the centre on 23rd March 2023. These centres are typically part of Government initiatives to improve access to healthcare services, especially for unserved communities in urban settings. The main aim of the UHWC is to give primary healthcare services, wellness and health promotion, access to essential medication, community engagement, and a Referral system.








E. DDC (DRUG-DE ADDICTION CENTRE)

It is a comprehensive rehabilitation setup for the addicts in the district of Jharsuguda which provides necessary support and an environment that promotes personal growth and discourages relapse. This centre was established in June 2017 with the support of District Mineral Foundation, Jharsuguda. Substance addiction is a significant issue that affects individuals and communities, and initiatives like this play a crucial role in helping people overcome their challenges and lead healthier lives. Individualised treatment plans tailored to each patient’s needs can improve outcomes. In the centre, different therapies are used to address the psychological and emotional needs of the patient.

SUCCESS STORY

Buromal, Jharsuguda resident Kailash Adha, 24, was admitted on January 19, 2023 by his father Sitaram Adha. He has been consuming drugs and alcohol for the past eight years. His socio-economic status is poor, and he is a member of a Scheduled Tribe. He is a daily wage worker. Due to alcohol consumption, which hampered his everyday life and relationships, his social life, financial situation, and mental and physical health were all negatively impacted. He had attempted suicide once before due to a mental disease like stress.

Kailash was first unresponsive and acted strangely. He was unable to sleep and requested sleeping pills. When someone spoke to him, he remained mute and became agitated towards both the counsellor and the other people. His hands and torso were trembling, and he was really frail physically. After 15 days of admission, he felt comfortable to talk with the counsellor and share his problems and feelings with others. Through proper medication & counselling, psycho education, psychological tests, Kailash’s condition became stable and his mental and physical condition improved slowly. After detoxification and staying 3 months in the centre, he started feeling good both physically and mentally and his abnormal behaviour changed to normal behaviour. Now, Kailash is in a good condition and doesn’t take alcohol. Moreover, he is properly maintaining his daily work (painter) and lives a healthy and alcohol-free life. His family members found his sound physical health/mental health condition and transformation of his habits as well as attitudes. They are very happy and thankful to the **Drugs De-addiction Centre**.

F. MOBILE MEDICAL UNIT

With the support of Annapurna Finance Pvt. Ltd., People’s Forum implemented the Mobile Medical Unit Project. This project is mainly focused upon the health status of the community in the villages who have lack of access to health care facilities, especially women. The project proposes to provide accessibility to quality preventive and promotive primary health care services across the target villages.


The program basically provides services such as health consultation, free basic medication and referral wherever required. The van is equipped with basic drugs, consumables, medical equipment, infection control measures, communication materials etc. Also, the van consists of a medical doctor, two nurses, a paramedical staff and a MPCW.




The following chart shows the male female ratio in the villages where the Mobile Medical Unit is working










ACADEMIC OVERVIEW

SUCCESS STORY

Ankita (Name Changed), a newborn child, was rescued by MISSION ASHRA on August 19, 2003, alongside her mentally ill mother, Laxmi Rao, aged 39. Due to her mother’s mental illness, Laxmi was unable to provide adequate care for Ankita, leading to the need for her protection and well-being. In accordance with the Juvenile Justice (Care and Protection) Act, 2015, the Child Welfare Committee in Khordha ordered that Ankita be placed in the Children’s Home/Special Adoption Agency (SAA) called “AAMA GHARA,” operated by People’s Forum.

Initially, Ankita resided at MISSION ASHRA with her mother but was transferred to AAMA GHARA in 2014. The dedicated staff members at AAMA GHARA ensured her education, shelter, nutritious meals, and physical and mental health needs were met. AAMA GHARA’s counsellors provide emotional support and care, valuable counselling, motivational support for her career aspirations, and holistic care. During her time at AAMA GHARA, Ankita learned essential social skills and proper behaviour towards others. She pursued her education at the Government School in Khordha and attended BHRAMARBAR GOVT. HIGH SCHOOL, Khordha. and AAMA GHARA provided her tuition for extra guidance to ensure academic progress.

Ankita is known for her sweet and positive attitude, actively participating in various programs. People's Forum made considerable efforts to nurture her skills and abilities, setting her on a path to success. In her future aspirations, Ankita aims to establish herself in Bangalore and, once financially stable, plans to reunite with her mother and provide her with the care and support she deserves.

Ankita's journey from a challenging start in life to her current path of success is a testament to her resilience and the support she received from People's Forum. It showcases the transformative power of care and protection for vulnerable children.

B. UJJAWALA HOME

In 2007 the “Ujjawala Home ” was launched by the Ministry of Women & Child Development to avoid trafficking of women and children for commercial sexual exploitation and provide them rehabilitation, rescue and reintegration facilities.

The primary causes of trafficking include poverty and the low status of women, among others. Due to its complexity and various factors involved, the trafficking of women and children for commercial sexual exploitation presents a particularly challenging issue.

Since 2009, People’s Forum has been running Ujjawala in Khorda District and since inception, 192 women have benefitted from this scheme. What is interesting is that the team provides them alternative solutions by giving vocational training so that when they go back to their regular life, they could manage their own expenses and become economically independent.

Types of counselling provided at Ujjawala Home:



Vocational Training: By providing vocational training we try to make them self-sufficient in future.

People's Forum organised camps to raise awareness about women trafficking and other issues. Till now, a total of 16 awareness camps has been organized in various villages.




C. SAKHI ONE STOP CENTRE

Sakhi one stop centre was set up after the incident of the 2012 Delhi Gang Rape outrage, to support women affected by violence, in private and public spaces, within family, community, and workplace. People’s Forum was selected as the nodal agency in 2015-2016 and it was the first centre to be started in the state as the pilot project at the Capital Hospital, Bhubaneswar. The centre is designed and equipped with all kinds of support including legal, medical, psychological, and short stay support for the women.

Key objectives:

- To provide integrated support and assistance to women affected by violence in both private and public spaces under one roof.
- To facilitate immediate, emergency, and non-emergency access to a range of services including medical, legal, psychological, and counselling under one roof to fight against any forms of violence against women.

Project Deliverable: In order to fight against all forms of violence against women, all OSCs provide 24/7 services and support to distressed women. They facilitate immediate, emergency, and non-emergency access to various services and support services listed below, all under one roof.

SUCCESS STORY

Rani (Name changed) is a woman in her 30s. Khordha, Odisha, is where she was born. She has endured a lot of hardships in her life. She was a widow with neither a house nor any money. She was totally powerless. She had no one to care for her, support her, or assist her.

One day, a helper showed up to assist her close to Ram Mandir. She was brought to the SAKHI One Stop Centre in Khordha by the individual. Rani was in her third trimester of pregnancy at the time, and she was extremely anxious. But SAKHI provided comfort, assistance, and support. She was then able to chat with the counsellor and relate her tale in a very comfortable environment provided by the counsellor.

To ensure Rani and her child were healthy, a doctor from SAKHI examined her. The SAKHI personnel knew Rani needed a safe place to remain, especially given that she was expecting a child. They then took her to the Capital Hospital so that she might receive the necessary care. Rani received more than simply a bed at SAKHI. She received healthy meals, medical assistance, and access to sympathetic listeners.

When it was time for her baby to be born, Rani went to the O & G Department. On the 20th of July in 2023, Rani became a mother to a lovely baby girl. It was a day full of hope and happiness.

Rani had trouble feeling her child, though. The SAKHI employees saw to it that the infant girl received the proper paediatric treatment. There was a lovely moment in August 2023. Both Rani's infant daughter and Rani are in perfect health and are prepared to leave the hospital and return to SAKHI. She received clothing and other necessities from SAKHI. Rani and her child moved to a new location in Kalinga Vihar after leaving SAKHI. They could begin their new lives in safety there. She wasn't travelling alone; those with golden hearts stayed by her side to assist her at all times.


A. ASHYA MISSION (BEGGARS REHABILITATION HOME)

Recently, the organization had witnessed a huge pandemic which affects millions of people, especially the economically weaker section of the society. Where the privileged section of society was able to cope up with the situation on the other hand, those without basic social security such as no roof, no family and living on the streets were unable to cope with the situation. Understanding their situation, the People’s forum initiated the rescue operation in order to provide immediate assistance to the needy.


Aim : To provide basic facilities to homeless people & also make them self-sufficient

Project Deliverable



Annual Status : Since 2020, People’s Forum has been able to provide shelters to **151** beneficiaries from which **26** people were successfully reunified with their family. Currently, **54** beneficiaries including male and female are living in the centre and hopefully in future the organisation will be able to reunite the rest of the residents in order to give them the good life that they deserve.

For their overall growth, according to the residents' interest, various activities are organized such as indoor-outdoor games, dance, singing etc. In order to give them better life and make them self-reliable, the team mainly focuses on providing them vocational training which includes incense stick making, candle making etc.



SUCCESS STORY

This is a significant achievement for our organization as, during the Covid pandemic, we successfully rehabilitated more than 500 individuals. Among them, Mr. Santosh (name changed) posed a unique challenge. Not only was he a destitute beggar, but he had also lost interest in life, living in despair. Rescued from Nayapalli, Bhubaneswar on 28/05/2020, he was initially uncooperative during the rescue, even resorting to throwing stones.

Upon admission to our center, Mr. Santosh gradually opened up to our counsellors, revealing his challenging past. Despite having two children, he faced neglect from his family after his wife's death, leading him to beg for survival. Formerly the president of the Auto Driver Union with a garage in Baliana, he lost both when his son sold the auto and garage for money.

Recognizing the need to instill hope in Mr. Nath's life, our counsellors played a crucial role. Over time, he engaged in recreational activities and, later, happily accepted the role of a gardener at the center. Using the address provided, the organization connected him with his family, counselling them to resolve their disputes. Eventually, a positive relationship was reestablished between Mr. Nath and his family, leading to their agreement to receive him back home.


Santosh lost everything in his life and expressed his desire to open a garage in his village, seeking assistance from the organization. In response, the HR and top management provided a small token to purchase tools and materials for his garage. He has now successfully opened the garage, earning a good income for his family. Santosh expressed gratitude, stating that Ashya Mission gave him new hope in his hopeless life, providing an opportunity to stand on his abilities. He added, "I can't forget Ashya Mission (People's Forum) till my last breath."

B. OLD AGE HOME (BHARASHA)


Old Age Home (BHARASHA) started in the year of 2019, is a residential facility in Jharsuguda district designed to provide housing and care for elderly individuals who may be living with disabilities & who are no longer able to live independently.

Since 2019, People’s Forum has been able to provide shelters to 153 senior citizens from which we have reunited 100 of senior citizens with their families. Currently we are handling 53 residents. Following chart shows the annual status for the year of 2022-23.



Various activities such as yoga, prayer, social & religious events are conducted to keep them active & away from indolence, to make sure they do not develop any diseases & remain mentally stable.



C. SOCIAL EQUITY CENTRE

People’s Forum is currently operating 100-seated Social Equity Centre, which is located at Kharavela Nagar with the objective to provide immediate shelter to the migrant labourers of Bhubaneswar. This project aims to secure the right of migrant labourer and to deliver secure shelter to reduce the life risk those stay at roadside. It provides dormitory and family rooms on rental housing to the construction workers at the rate prescribed by the Labour & ESI Department, Government of Odisha.

- **NUTRITIONAL SECURITY** -

MID-DAY MEAL (ANNAPURNA ANAND BHANDAR)

Mid-day meal aims to improve attendance, retention, and the overall health of students, especially those from disadvantaged backgrounds. With the support of the department of school and mass education, Govt. of Odisha, the People’s Forum is implementing the Midday Meal Programme under government guidelines to ensure that school-going children receive healthy, nutritious food.

The programme has now covered 41 schools; 20 schools in Khorda Municipality & 21 schools in Jatni municipality. Approximately 7000 school-going children receive healthy and nutritious meals every day through this program.

- **ANIMAL WELFARE** -

People’s Forum facilitates across the city of Bhubaneswar, which addresses many aspects of Animal welfare which includes rescue and care, adoption and foster, geriatric care and many more.

We have two centres that is exclusively working for the welfare of animals that is,

- 2. Goshala (In Collaboration with H&UD Department, Govt. of Odisha)

1. COW SHELTER & TREATMENT CENTRE, SURKABADI

(OWN INITIATIVE)

It is an own initiative of People’s Forum that is working for the welfare of cattle’s starting from shelter, protection, feeding, to looking after their medical facilities and treatment.

Along with feeding, treating and taking care of our own cattle’s, we also have provision of helping out the local people who cannot afford the treatment. We provide them with basic amenities from surrounding villages like **Nelibadi, Darpannarayanpur, Badmala, Patana** etc.




- BUSINESS CORRESPONDENCE -




